The trip will run from the $22^{nd} - 26^{th}$ January 2026 with the competition taking place from the $23^{rd} - 25^{th}$. Athletes will be training on Thursday 22^{nd} upon their arrival.

If you fail to complete the information required by the deadline a reserve will be invited. The athlete contribution for this event is £200. The team hotel (Ramada Encore) is booked for half board, therefore some additional spending money will be required for lunch items and snacks throughout the trip. Team managers will arrange trips to the supermarket to allow the swimmers to stock up.

Four entries (using long course times) per swimmer will be covered by the Swim England South East Region, should you wish to enter more you will need to pay for the additional entries. Athletes should select at least one event per day. Additional entries will cost £15 per event, you will be contacted regarding payment for these after the entries have been accepted.

You are responsible for arranging your own travel insurance and bringing your policy document.
